This year's event offers two races, an 8 mile distance and a 4 mile distance, and a 2 mile fun run/walk. This event is FAMILY FRIENDLY and open to Runners and Walkers! The race path for these events is a 100% trail course winding over McPherson County's beautiful Meadowlark Trail.

This year all of the options will be "out and back" routes and will begin and end at the Meadowlark Trail Head

8 Mile Race

The 8 mile option will take participants north 4 miles to Pawnee Road before participants will be directed to turn around and head back to the Trail Head.

4 Mile Race

The 4 mile option will take participants north 2 miles to Navajo Road before participants will be directed to turn around and head back to the Trail Head.

2 Mile Fun Run/Walk

The 2 mile option will take participants north 1 mile to Mohawk Road before participants will be directed to turn around and head back to the Trail Head.
